AFFIDAVIT OF KENNETH R. TOWNSEND

Before me personally appeared Kenneth R. Townsend, who being first duly sworn deposes and says as follows:

I am the President and Registered Agent of Columbia Home Builders, Inc. On December 16, 2005 I went to Columbia County Bank to obtain a business loan and learned from loan officer Justin Teuton (telephone 386-752-5646) that the 2005 UBR was not filed and that the corporation had been dissolved on September 16, 2005. That was how I first learned of the dissolution and the first reminder I had of the need to file the 2005 UBR. I never received the regular notice to file the 2005 UBR because my address, as Resident Agent, and the address of Columbia Home Builders, Inc. had changed. The reason the addresses changed was Columbia County's adoption of the new 911 addressing system. Neither Columbia Home Builders, Inc. nor I moved to a new location, but the County's new addressing system caused new addresses to be assigned to both of us.

The failure to file the 2005 UBR was unintentional and was the direct consequence of the adoption of the County's new 911 addressing system and the resulting non delivery of your notice to file the 2005 UBR. Since I did not receive the notice to file the 2005 UBR and the failure to timely file the 2005 UBR was unintentional, I request that the \$600 reinstatement be waived. In anticipation that you will grant this request, I have enclosed the reinstatement application and a business check in the amount of \$150.00 to cover the annual report and supplemental fees for 2005. I have also enclosed the 2006 UBR and a separate check in the amount of \$150 to cover the 2006 filing fee.

I apologize for not filing the 2005 UBR and not responding to the dissolution of the corporation in a more timely manner, but I was unaware of this situation until applying for a business loan on December 16, 2005 and could not consult with my attorney until today because of his busy schedule and the Christmas and New Year holidays.
