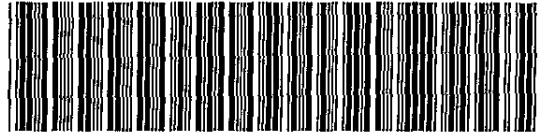


ARTICLE IX - AMENDMENT




