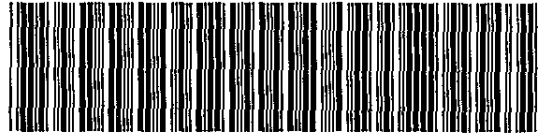

The name of this corporation is **PROVIDENCE TREE SERVICE, INC.**

ARTICLE II

The corporation is to exist perpetually, commencing on the date of filing and recording of these Articles.

ARTICLE III

This corporation is organized for the purpose providing tree and brush removal and trimming and any other legitimate business.

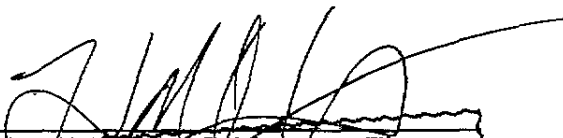

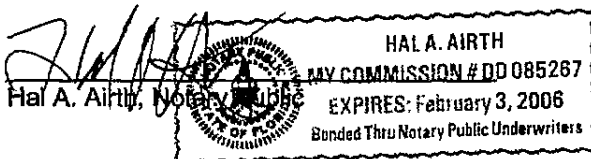
