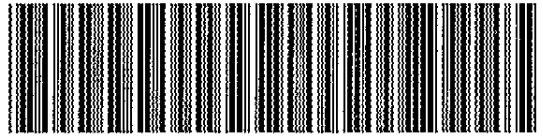

Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III. Capital Structure

A. The Board of Directors can create any type of Capital Structure necessary or the operation of the corporation. There can be different stocks of Par Value and Non-Par Value.

Article IX. Officers

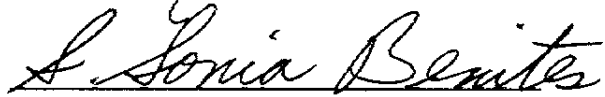

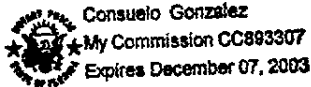
