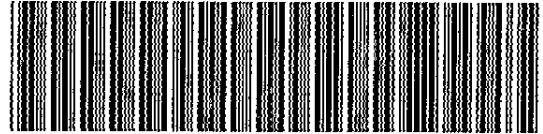

The name of the corporation is Gordon J. Cregg, Inc.

The name and address of the incorporator is Gordon J. Cregg, 11123 Scott Mill Rd., Jacksonville, FL 32223.

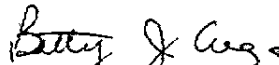
ARTICLE SEVEN
