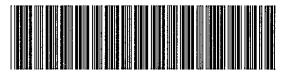

THE UNDERSIGNED INCORPORATOR, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME.

The name of this corporation is EHRET & WELCH BUILDERS, INC.

ARTICLE II. EFFECTIVE DATE.

The effective date of existence of this corporation shall be January 1, 2004.

ARTICLE III. PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation shall be 245 W. Blue Springs Ave., Orange City, Florida 32763.

ARTICLE IV. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.
