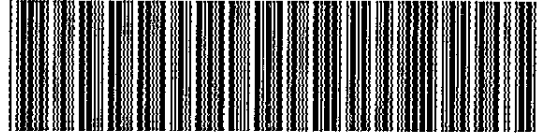



The name and address of the incorporator is Mike Petroff, 2918 Cherokee Ave., Jacksonville, FL 32210.


