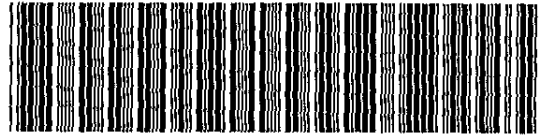

I the undersigned, hereby associate myself for the purpose of becoming a corporation under the laws of the State of Florida, the powers, rights, privileges, and immunities hereinafter mentioned, and we hereby make, subscribe and acknowledge and file with the secretary of the State of Florida with Articles of Incorporation, and to this end we do, by this articles, set forth:

Article I

The name of this Corporation (which is hereinafter called the "Corporation") is: Bosaq Corporation Inc. Its principal business shall be carried on at 7221 Grandview Blvd., Miramar, FL 33023 and at such other places points in the State of Florida, time be authorized by the Board of Directors.

Section I

Section 4


