**ARTICLE I

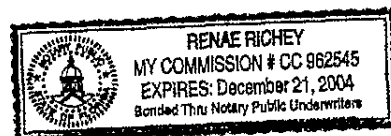


