ARTICLES OF INCORPORATION

OF

GRANTCHAROV, INC.



The undersigned subscribers to these Articles of Incorporation, each being a natural person competent to contract, hereby file the following articles of incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is GRANTCHAROV, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing on the date of filing of Articles of Incorporation by the Department of State.

ARTICLE III. GENERAL PURPOSE

This corporation is organized for the purpose of operating a ceramic tile installation business and the like, and for the purpose of transacting or engaging in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV. CAPITAL STOCK


