

The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The name of the corporation (hereinafter called the "corporation") is BREAKEVEN ASSOCIATES INC. The mailing address and principal place of business of the corporation is 14141 U.S. Highway One, Juno Beach, FL 33408.

<u>SECOND</u>: The duration of the corporation shall be perpetual.

Board of Directors to such persons, firms, corporations, and associations, and for such lawful consideration, and on such terms, as the Board of Directors in its discretion may determine, without first offering the same, or any thereof, to any said holder.

SIXTH: The address of the initial registered office of the corporation in the State of Florida is 14141 U.S. Highway One, Juno Beach, Florida 33408, and the name of its initial registered agent at said address is Darren R. Goldstein.
