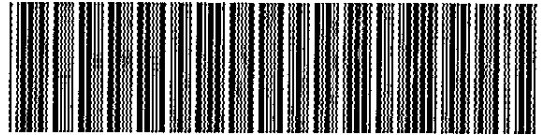

ARTICLE I. NAME

The name of this corporation is

ARTICLE II. DURATION

This corporation shall commence January 1, 2004, and shall have perpetual existence.

ARTICLE III. PURPOSE

ARTICLE IV. CAPITAL STOCK

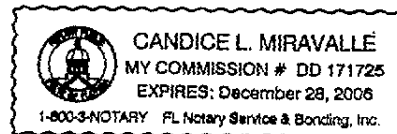


