ARTICLE I. CORPORATE NAME

The name of this Corporation is Joseph F. Croke, PA.

ARTICLE II. CORPORATE PRINCIPAL OFFICE AND MAILING ADDRESS

The Corporation principal office and mailing address is 9827 51st Ave. N St. Petersburg, FL 33708.

ARTICLE III. NATURE OF BUSINESS

The nature of the business to be transacted by this Corporation is for a Real Estate Agent business permitted under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK

The maximum number of share of stock that this Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock without par value.
