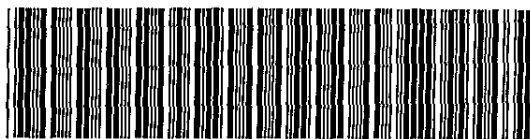

ARTICLE I. NAME

The name of this corporation is  
VINCE'S FENCES INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

This corporation is organized for the purpose of



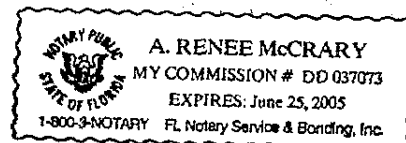
