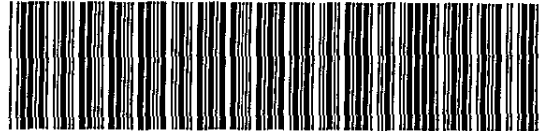

ARTICLE ONE

The name of the Corporation is BABER GROUP LANDSCAPERS, INC.
