

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a professional service corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME OF CORPORATION

ARTICLE II

GENERAL NATURE OF BUSINESS


