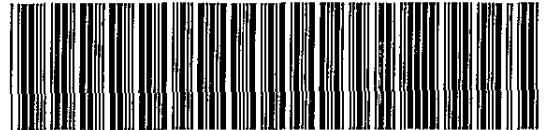



**ARTICLES OF INCORPORATION  
OF  
ACCELL TAX & ACCOUNTING SERVICES, INC.**

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

**ARTICLE I: NAME**

The name of the Corporation is Accell Tax & Accounting Services, Inc.

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 10710 Firebrick Court, Trinity, Florida 34655.

**ARTICLE III: CAPITAL STOCK**

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 100 shares of common stock with a par value of \$1.00 per share. The term of existence of this corporation is perpetual.


#### **ARTICLE IX: BY-LAWS**


