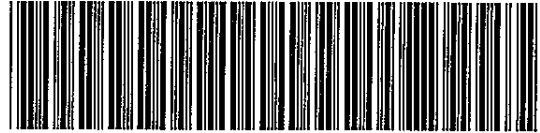

The undersigned subscribers to these Articles of incorporation, Natural person competent to contract hereby form a corporation under the laws of the State of Florida.

ARTICLE 1 - CORPORATE NAME

This corporation shall exist perpetually unless dissolved according to Florida law.




