ARTICLES OF INCORPORATION

OF

MY WAY SERVICES, INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, Chapter 607, adopts the following articles of incorporation for the purpose of organizing a business corporation:

ARTICLE I

The name of the corporation ("Corporation") is MY WAY SERVICES, INC.


