## ARTICLES OF INCORPORATION OF

### Taylor Jenkins Homes, Inc.

*The Undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

#### ARTICLE I - NAME

The name of the Corporation is: **Taylor Jenkins Homes, Inc.**
