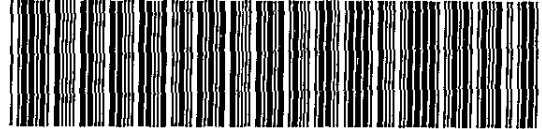

The undersigned incorporation hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I

The name of the Corporation shall be **ALL ABOUT FACE HAIR & NAILS, INC.**

ARTICLE II

The address of the principle office of this Corporation shall be 4960 N Dixie Highway, #201A, Oakland Park, Florida 33334 and the mailing address shall be the same.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 500 shares of common stock having a par value of \$1.00 per share.
