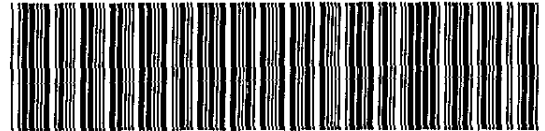

ARTICLE I. NAME

The name of this corporation shall be KEITH A. TURNEY BUILDING CONTRACTORS, INC.

ARTICLE II. COMMENCEMENT & DURATION
