The undersigned incorporator hereby certifies to the following in order to form a corporation of the state of Florida.

#### **ARTICLE I - NAME**

The name of this corporation is SHERIDAN'S VINYL SIDING INSTALLERS, INC.

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence.

#### ARTICLE III - PURPOSE

The general purposes for which the Corporation is organized are the following:
