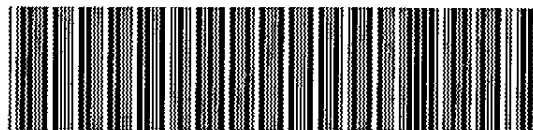

ARTICLES OF INCORPORATION

XTREME ALUMINUM, INC.

EFFECTIVE DATE

1-1-04

ARTICLE I. NAME

The name of the corporation shall Xtreme Aluminum, Inc.

ARTICLE II. ADDRESS

The principal place of business and mailing address of the corporation shall be 6431 NE 156th Court, Williston, FL 32696.

ARTICLE III. DURATION

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon filing with the effective date of this corporation January 1, 2004.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock on one class only, having a par value of \$1.00 per share.

ARTICLE V. INITIAL REGISTERED AGENT AND STREET ADDRESS
