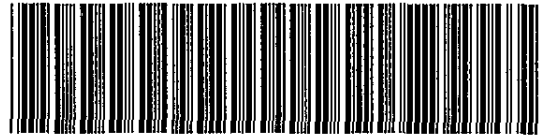

ARTICLES OF INCORPORATION
OF

The undersigned incorporators for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be GLYNN BRAZIL PLUMBING, INC.

ARTICLE II - PRINCIPAL OFFICE
