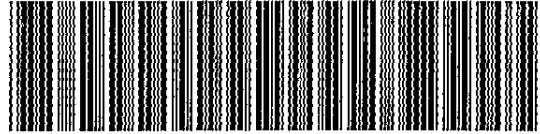

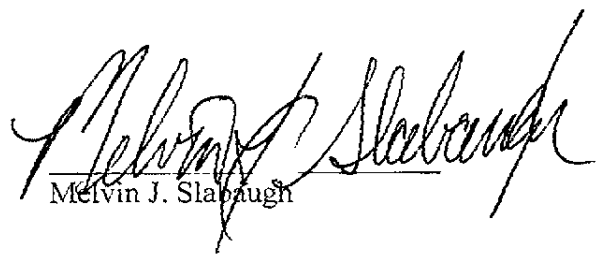

The power to adopt, alter, amend, or repeal by-laws will be vested in the shareholder.

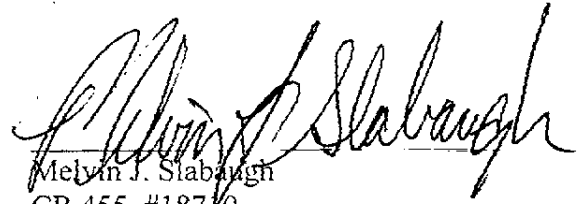
#### **VIII. MANAGEMENT BY SHAREHOLDER**
