### ARTICLES OF INCORPORATION

### ARTICLE I - NAME

The name of this corporation is FIKES PRESSURE CLEANING SERVICE,

### ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date of filing of these Articles.

### ARTICLE III - PURPOSE

At each election for directors, every shareholder entitled to vote at such election shall have the right to vote, in person, or by proxy, the number of shares owned by him for as many persons as there are directors to be elected at that time and for whose election he has a right to vote or to accumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principal among any number of such candidates.

Section 2. <u>Pre-emptive Rights</u>. Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds,
