

ARTICLES OF INCORPORATION

OF

FAMILY BUSINESS CONSULTING. INC.

ARTICLE I - NAME

The name of this corporation is FAMILY BUSINESS CONSULTING, INC.

ARTICLE II - PRINCÍPAL OFFICE

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".
