

# ARTICLES OF INCORPORATION OF THE CONNECTION SERVICE, INCORPORATION OF STATE

The undersigned incorporators for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

#### ARTICLE I - NAME

The name of this corporation is The Connection Service, Inc. (hereinafter referred to as the "Corporation").

# ARTICLE II - PRINCIPAL OFFICE
