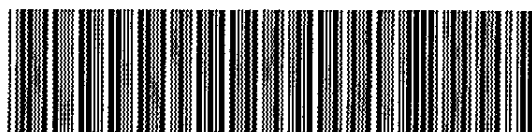


#### **ARTICLE IX - AMENDMENT**
