ARTICLES OF INCORPORATION OF FRANK KING CARPETS, INC.

ARTICLE I NAME

The name of this Corporation is Frank King Carpets, Inc.

ARTICLE II DURATION

This Corporation shall have perpetual existence. The effective date of this Corporation shall be the date of filing of these Articles.
