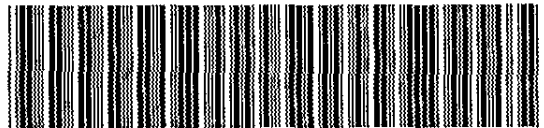

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be M & B MARKETING, INC.

The address of the principal office of this corporation shall be 5473 St. Regis Way, Port Orange, FL 32128, and the mailing address is the same.

ARTICLE II

NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III

CAPITAL STOCK


ARTICLE IX

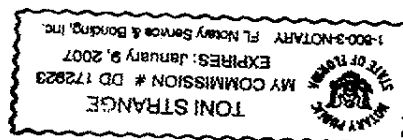


