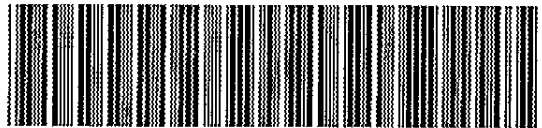

1. Introduction. Melvin E. Bigelow, being duly sworn, deposes and says:

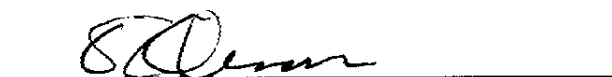

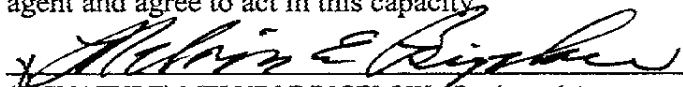
