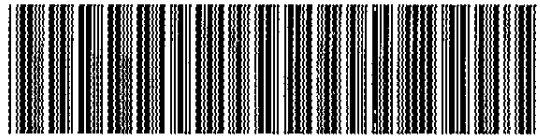

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be: Steve's Floor Covering, Inc. The principal place of business of this corporation shall be 1202 North Ridgewood Avenue, Holly Hill, Florida 32117, and the mailing address of business shall be 1202 North Ridgewood Avenue, Holly Hill, Florida 32117.

**ARTICLE II. NATURE OF BUSINESS**

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having \$1 par value per share.

The name and address of the initial director and officer of the corporation who shall hold office for the first year of the corporation, or until his successors are elected or appointed are:


