

AMENDMENT TO ARTICLES OF INCORPORATION
OF FINE LINE ARCHITECTURAL DETAILING, INC.

The undersigned, being the sole incorporator, sole director and president of Fine Line Architectural Detailing, Inc., a corporation which has not yet issued shares (so that shareholder approval of this amendment is not required), files the following Amendment to the Articles of Incorporation of Fine Line Architectural Detailing, Inc.:
