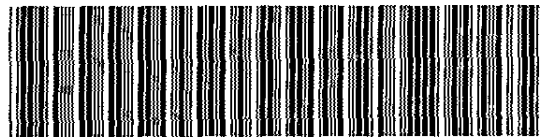

ARTICLE I: NAME

(\$1.00) Dollar per share par value.


