The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article I - Name and Address

The name of this Corporation is Gelph, Inc. The principal place of business of this Corporation shall be 8309 N. Thatcher Ave., Tampa, Florida 33614, and the mailing address shall be P.O. Box 271429, Tampa, Florida 33688-1429, or such other place as may be designated by the Board of Directors.




