

ARTICLES OF INCORPORATION
OF
RAO PRODUCTIONS, INC.

ARTICLE I

The name of the corporation is RAO PRODUCTIONS, INC.

ARTICLE II

This corporation shall have perpetual existence, and shall commence upon the signing and acknowledging of these Articles.

ARTICLE III



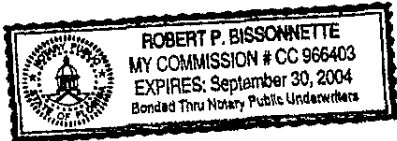
