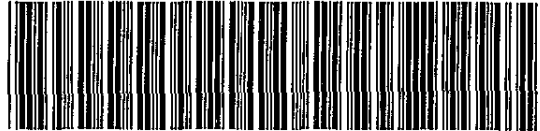

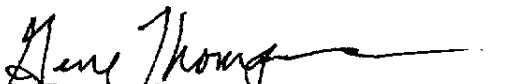
ARTICLE VIII. INDEMNIFICATION

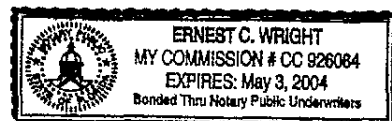

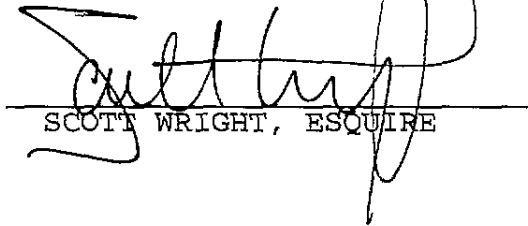

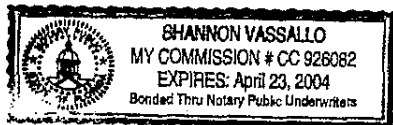
