TALLAHASSEE FLORIDA

The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

#### ARTICLE I

#### <u>NAME</u>

The name of the Corporation shall be CL INVESTMENTS & ASSOCIATES, INC.

#### ARTICLE II

#### PRINCIPAL OFFICE

The initial principal place of business and mailing address of this Corporation shall be: 17911 NW 68th Avenue, Suite P-202, Miami, Florida 33015.

#### ARTICLE III

#### **PURPOSES**

The purpose for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:


