ARTICLE V - CAPITAL STOCK


The corporation is authorized to issue ONE THOUSAND (1,000) Shares of \$1.00 par value common stock.



ARTICLE IX - BY-LAWS

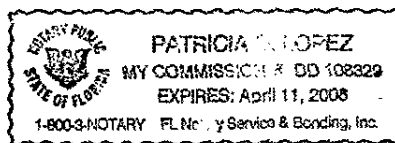
