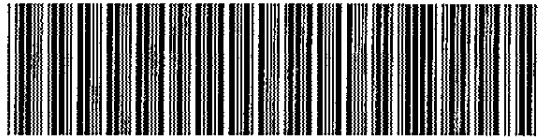



OF




