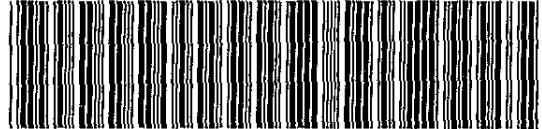

OF

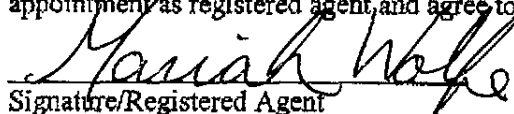
