BYLAWS



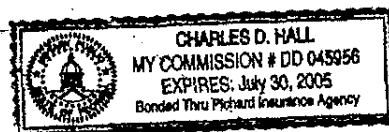
