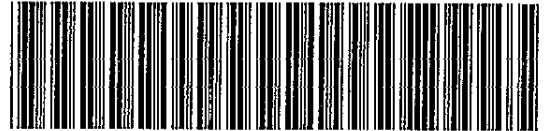



ARTICLE 1. - NAME

The name of the corporation is NRF ENTERPRISES, INC.

ARTICLE 11. - AMENDMENT


