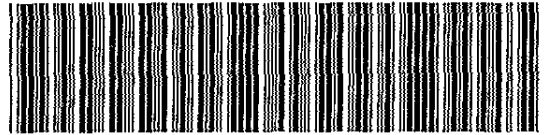

ARTICLES OF INCORPORATION

I, the undersigned, being of full age, sui juris and resident of the United States, hereby file these Articles for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liability, privileges and immunities of a corporation for profit.

ARTICLE I

The name of this corporation shall be ALL SURFACE PAINTING NSB, INC.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida, but is primarily designed to engage in contracting for the painting of structures.

ARTICLE III

The total authorized capital stock of this corporation shall be 1000 shares of common stock of par value of \$1.00 per share. Said stock shall be paid for in cash or property, labor or services at a just valuation to be fixed by the incorporators in the manner provided for by statutes, and the stock shall be issued in accordance with such valuation.

ARTICLE IV

The amount of capital with which this corporation shall begin business shall be not less than One Hundred (\$100.00) Dollars.

#### ARTICLE V

The corporation shall have perpetual existence unless sooner dissolved according to law.

#### ARTICLE VI

The principal place of business and general office of this corporation shall be at 629 Goodwin Avenue, New Smyrna Beach, Florida 32169, with a mailing address of P. O. Box 3014, New Smyrna Beach, Florida 32170, but it may maintain offices and transact business at such other places, either within or without the State of Florida, as the Board of Directors may from time to time provided by resolution. The registered agent for the corporation shall be William L. Ross, Jr., whose business office is located at 221 North Causeway, New Smyrna Beach, Florida 32169, which office is hereby designated as the registered office of the corporation.

#### ARTICLE VII

The business of the corporation shall be conducted by a president, a vice-president, a secretary and treasurer, and a board of directors not less than the minimum required by law, or more than three, the exact number to be determined by the by-laws of the corporation. Only the president need be a stockholder of this corporation. All stockholders shall possess voting power. Each of the above designated officers, as well as the board of directors, shall be elected at the annual meeting of the stockholders, and shall hold office until their successors are elected or appointed, unless otherwise provided in the by-laws. 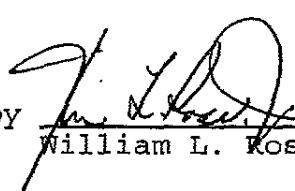
