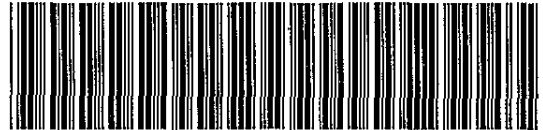



**ARTICLES OF INCORPORATION
OF
D & S DRYWALL-FRAMING, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a professional service corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME OF CORPORATION

The name of this corporation shall be **D & S DRYWALL-FRAMING, INC.**

ARTICLE II

GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be providing drywall, framing and related services.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any time is One Hundred (100) shares of common stock having a par value of One Dollar (\$1.00) per share.

AUTHORIZATION OF INCORPORATION


This corporation shall be deemed to be in effect upon execution of these Articles of Incorporation.



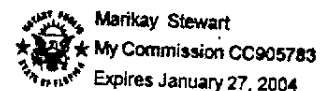


