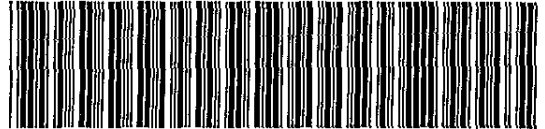



ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is Bill Ward Tile Company, and the principal business and mailing address of the Corporation is 6506 Kennerly Road, Jacksonville, Florida 32216.

ARTICLE II - COMMENCEMENT AND DURATION

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence upon the date of filing of these Articles of Incorporation. This Corporation shall have perpetual existence.
