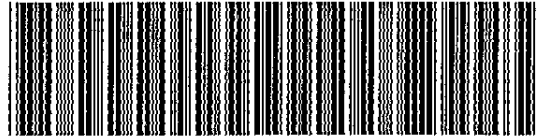

This corporation is to exist perpetually, unless sooner dissolved according to Law.


**ARTICLE IX**
