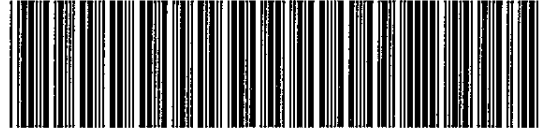

The undersigned, for the purpose of forming a corporation, under the Florida Corporation Act, does hereby adopt the following ARTICLES OF INCORPORATION:

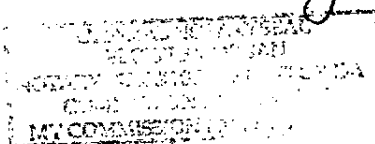
